## REGISTRATION AFFIDAVIT OF ALIEN FEMALE

(Under proclamation of the President dated April 19, 1918.)

The registration affidavit must be filled in, signed, and sworn to in triplicate and accompanied by four unmounted photographs of the registrant not larger than 3 x 3 inches in size, on thin paper with light background. These photographs must be of the shoulders and full face of the registrant without hat or head covering. All four photographs should be signed by the registrant across the face of the photograph so are not to obscure the features, if the registrant is able to write.

The affidavit need not be filled out before, but must be signed and swern to before a registration officer, who will full in the description and take the finger prints of the registrant. If the registrant is unable to write, she must make her mark in the signature space and affix her left thumb print in the space indicated for the same opposite the signature space. The registration officer will also fill in the marginal notations on the first page, and i registration card is not issued be shall append to the registration officers are authorized to administer the cath hereto to all registrants.

Persons required to register should understand that in so doing they are giving proof of their peaceful disposition and their intention to conform to the laws of the United States.

Each registrant should read carefully the form of registration affidavit and ask the registration officer for explanation on all points not clear to the registrant before attempting to fill out the blank. The registration officers are instructed to give the registrants all possible ald in the way of explanation and advice.

The finger priving is a method of identification and the taking of the finger private is not to be deemed an imputation that the registrant is not a law-abiding person.

82° Norm.—The registrant is hereby informed that she must again present herself before the registration officer who took her affidavit, after 10 days but within 15 days from the last day fixed for registration in her registration district, to obtain a registration out upon which she must sign her name or make her mark in the presence of the registration district.
